

Product Warranty

SWAYMAR MARINE ENGINEERING LTD WARRANTS TO THE ORGINAL PURCHASER ONLY (BUYER) AS SHOWN BELOW, ITS PRODUCTS AS PROVIDED AND MARKED BELOW, AND SUBJECT TO THE LIMITATIONS, TERMS, CONDITIONS AND EXCLUSIONS SET FORTH HEREIN:

For private pleasure use all **Swaymar Marine engineering Ltd** engines are warranted against all defective workmanship and components for a period of 12 months after purchase or 400 hours whichever occurs the soonest.

In the event that an hour meter is not fitted to a private pleasure boat the usage shall be deemed to be 40 hours per month.

For commercial enterprise all **Swaymar Marine engineering Ltd** engines are warranted against all defective workmanship and components for a period of 6 months after purchase or 200 hours whichever occurs the soonest.

In the event that an hour meter is not fitted to a boat used for commercial enterprise the usage shall be deemed to be 45 hours per week.

It is the responsibility of the owner to ensure the exhaust system used is suitable for the purpose and will not under any circumstances allow water back into the engine, should water for any reason enter the engine via the exhaust ports the warranty is immediately void.

Warranty Disclaimer

All Swaymar Marine engineering Ltd products must be correctly installed by a qualified marine technician.

This warranty expressly excludes any damage caused by the failure of ancillary components, adjustments, tune-ups, freezing, neglect, lack of maintenance, accidents, abnormal operation or improper installation or service, participating in or preparing for racing and water ingress. **Swaymar Marine engineering Ltd** recommends that all exhaust manifolds and risers are replaced prior to installation of new engines. Damage or failure caused by parts not supplied by or that have not been inspected and refurbished by **Swaymar Marine engineering Ltd** is expressly excluded.

NB: Under no circumstances do we refurbish cast iron exhaust manifolds.

NB: Extreme caution should be taken when fitting previously used cast iron inlet manifolds & exhaust manifolds as these are prone to failure and the cause of most engine problems.



This warranty will not apply to: haul out, launch, towing and storage charges, telephone or rental charges of any type, inconvenience, or loss of time or income, or other consequential damages, removal and/or replacement of boat partitions or access to product.

Claims shall be made under this warranty by contacting **Swaymar Marine engineering Ltd,** immediately and subject to inspection at our works.

Purchaser shall pay for all related transportation charges and/or time. Our obligation under this Warranty shall be limited to repair or replacement of defective parts or faulty workmanship and associated labour, and is at the sole discretion of **Swaymar Marine engineering Ltd.**
